BITTERROOT BUS PROVIDES ON-DEMAND, CURB TO CURB SERVICE WHICH REQUIRES 24 HOUR ADVANCE NOTICE FOR SCHEDULING PURPOSES. BITTERROOT BUS PROVIDES SERVICES TO SENIORS, THE DISABLED, AND THE GENERAL PUBLIC THROUGHOUT RAVALLI COUNTY. BITTERROOT BUS ALSO PROVIDES TWO WEEKLY TRIPS FROM RAVALLI COUNTY TO THE MISSOULA METRO AREA. DURING THE PAST FISCAL YEAR, 13,312 RIDES WERE PROVIDED TO 316 CLIENTS.

DURING THE FISCAL YEAR, 30,304 MEALS ON WHEELS WERE SERVED TO A TOTAL OF 315 CLIENTS IN NEED. IN ADDITION, THE COUNCIL EMPLOYS A CERTIFIED LOCAL OMBUDSMAN WHO PROTECTS RESIDENT RIGHTS FOR PEOPLE LIVING IN LONG-TERM CARE FACILITIES. DURING THE FISCAL YEAR, THERE WERE 8,716 CONTACTS MADE FOR INFORMATION, ASSISTANCE AND THE OMBUDSMAN PROGRAMS COMBINED. IN ADDITION, 971 LOANS OF DURABLE MEDICAL EQUIPMENT WERE MADE. THE ORGANIZATION PROVIDED OVER 818 HOURS OF MONEY MANAGEMENT, AND 199 CLIENTS RECIEVED LIFE ALERT MEDICAL ALERT SYSTEMS.
