BITTERROOT BUS SYSTEM PROVIDES ON-DEMAND, CURB TO CURB SERVICE WHICH REQUIRES 24 HOUR ADVANCE NOTICE FOR SCHEDULING PURPOSES. BITTERROOT BUS PROVIDES SERVICES TO SENIORS, THE DISABLED, AND THE GENERAL PUBLIC THROUGHOUT RAVALLI COUNTY. BITTERROOT BUS ALSO PROVIDES TWO WEEKLY TRIPS FROM RAVALLI COUNTY TO THE MISSOULA METRO AREA. THERE WERE 9,488 RIDES PROVIDED TO CLIENTS DURING THE FISCAL YEAR.

DURING THE FISCAL YEAR, 35,930 MEALS ON WHEELS WERE SERVED TO CLIENTS IN NEED. IN ADDITION, THE ORGANIZATION PROVIDED MONEY MANAGEMENT SERVICES TO 134 CLIENTS.
